The Guam National Tennis Federation (GNTF) is seeking a Captain/Coach for the upcoming 2020 Junior Davis Cup and Junior Fed Cup. The Regional Pre-qualifying Event will be held in Jakarta, Indonesia from 22 February to 1 March 2020.

The position is responsible for the development, selection, and management of the GNTF Junior Davis Cup and Junior Fed Cup teams. The core function will be providing guidance in the month leading up to the Junior Davis Cup and Junior Fed Cup Competition and provide coaching during the events to maximize the players' potential to place the Guam team in viewing position.

Main duties and responsibilities:

- Manage and coach the Junior Davis Cup and Junior Fed Cup teams at any Tie held throughout the year
- Assist in selecting the Junior Davis Cup and Junior Fed Cup teams and make recommendations to the GNTF Board
- Support the Junior Davis Cup and Junior Fed Cup Players throughout the year and maintain communication between Ties
- Team preparation, training, and motivation for Junior Davis Cup and Junior Fed Cup Ties
- Some media and PR requirements
- Represent GNTF at the ITF Junior Davis Cup and Junior Fed Cup Meetings preceding Ties
- Develop a Junior Davis Cup and Junior Fed Cup Plan, including goals for the team and individual players
- Submit a report within 14 days of any Tie outlining the team performance and progress

Persons interested in applying shall have a coaching qualification as well as a high level of tennis playing, with the ability to make on court decisions in regards to strategies during Ties. GNTF is looking for a candidate with demonstrated ability to manage, evaluate and motivate players while maintaining a positive attitude. Candidates must be flexible in regards to availability for 2020 Junior Davis Cup and Junior Fed Cup events.
